# Security Issues

## ✓ High Severity Issues

## ✓ Low Severity Issues

### 1. Out of gas

Issue (ScrapMaster, ConstipatedPool):

- The `massUpdatePools()` function can fail due to block gas limit if the pool size is too big.

Recommendation:

Check that the pools number is not too big.

## Owner privileges (In the period when the owner is not renounced)

- **ConstipatedPool:**
  - Owner can change pid's alloc point.
  - Owner can change pid's deposit fee.
  - Owner can change pid's lockupDuration.
  - Owner can change shitiumPerBlock.
  - Owner can change fee address.
- **ScrapMaster:**
  - Owner can change pid's alloc point.
  - Owner can change pid's deposit fee.
  - Owner can change shitiumPerBlock.
  - Owner can change fee address.
- **LatrinePool:**
  - Owner can withdraw tokens (except stakedToken).
  - Owner can change bonus end block (stop rewards).
  - Owner can change poolLimitPerUser value.
  - Owner can change reward per block.
  - Owner and Manager change start and end blocks.
  - Owner can change manager address.
  - Owner and Manager can restart the contract.
  - Owner can withdraw ERC20 tokens from the contract.
  - Manager can recalculate reward per block.
  - Manager can change rewardMaxTxAmount.
- **ShitiumToken:**
  - Minters can mint.

# Conclusion

Smart contracts contain low severity issues! The further transfers and operations with the funds raise are not related to this particular contracts.
